OLD BUSINESS

- A. The following motions were made and approved unanimously via email and are now confirmed at this meeting for approval by the Committee. The Committee voted unanimously to approve the following motions:**
- a. To place more mulch on Barred Owl – This is an on-going project.**
 - b. Have the grass mowed one more time this year – Scheduled for September 19th**
 - c. A cover for the Kuboda, Mike Stracka (PMP) will provide pricing. – The order has been placed. The approximate cost was \$260.00.**
- B. The Committee discussed potential purchases for:**
- a. Mud tires for the Kuboda. Once pricing is obtained from Mike Stracka (PMP) the Committee will discuss the cost effectiveness. – The order has been placed and cost approximately \$250.00.**
 - b. New Message board. Pricing will be provided by Mike Stracka (PMP) for further discussion. – Costs are estimated at \$300.00. Review to purchase.**
 - c. Debi and Carlos to determine the color and quantity of ribbons needed for Committee use.**
- C. The Committee also discussed on-going purchases on an “as needed” basis such as tools and gas. Purchases that have been placed:**
- a. Pole Hedge Trimmer - \$235.00**
 - b. Chains for the Saws - \$300.00**
 - c. One Bar for Each Saw - \$250.00**
 - d. Gravel for HPR gravel road - \$900.00**
- All items should be received between September and October.**
- D. The Committee decided not to purchase a bush mower for the Kuboda.**
- E. The Committee discussed and is considering switching the chain and gates at HPR – Still to be determined.**
