Standing Committee Reports

February Grounds Committee was canceled due to a community power outage. Unanimous votes were taken via email to approve the following:

- Advantage proposal to install replacement trees in all neighborhoods at a cost of \$17,099
- Email and letter blast to CountrySide and Environs neighbors with information on how to minimize the impacts to the storm water drainage pond in Belmont due to the overapplication of fertilizers, herbicides and pesticides
 - February Finance Report presented by Jeff Kretsch. Meeting minutes are in the March Courier
 - Facilities Report presented by Pat Bour. Lindenwood Pool in need of repairs to fix the water leaks. At a minimum the pool skimmers to be replaced in 2022 with additional work to follow in future years. Full meeting minutes are in the March Courier.
 - No CRC Report presented
 - No HPR report given. Discussion by NAC of Loudoun County funding of Potomac Heritage Trail
 extension through Horsepen Run with implications for additional foot traffic through
 CountrySide's property.
 - NAC Liaison to BoD report given by Pat Bour. Dan Castan of the Welbourne NAC reviewed the limitations of our community to change the zoning guidelines regarding short term rentals due to a Memorandum of Understanding that was signed by the developer and the BOS prior to the development of CountrySide. Jeff Kretsch questioned how a Memorandum of Understanding could hold up to a legal challenge. More to come...



Review of applications

The Rokeby NAC reviewed 8 applications as follows:

- 123 Peyton Road. Homeowner joined the meeting via phone. Application to widen the existing driveway by 8' was approved 4-0 contingent on the widening to be contiguous with and of the same material as the existing driveway. Lisa to send homeowner an email with our decision as he was having some difficulty comprehending everything during the meeting.
- 3 West Court. Homeowner joined the meeting via phone. There were 2 applications and both were approved 4-0.
 - Remove trees and bushes and replace with grass, install 28 Cypress trees along the fence. Replace existing concrete pool deck with pavers and expand the size of the deck
- 119 Moss Road. There were 2 applications submitted and both were approved 4-0. Replace front entry door, storm door and rear entry door. Appearance and colors closely match the existing.
 - Install 20'x15' concrete pavers for a patio in the rear of the house.
- 154 Peyton Road. There were 3 applications submitted and all were approved 4-0. Change the material and color of the siding and shutters and change the trim and garage color.
 - Replace existing wood single pane wood windows with vinyl double pane windows. Wrap existing wood trim.
 - Install power attic fans above the kitchen/garage and main house.

NAC Liaison to BOD: Pat and Jeff. Short Term Rental discussions. Impact of the original Memorandum Of Understanding (MOU) between 437 Land Co. and Loudoun County (LC) regarding zoning. Dan Castan clarified the MOU – lawsuit with LC, CS is under the 1973 zoning ordinance so not covered under 1993 zoning ordinance. So, LC zoning changes will not affect CS and Mirror Ridge. To be included under zone 2018, residents need to send opinions to Julie Briskman. Residents would have to request the Board of Supervisors for relief from the 1973 zoning. BOD is working on updating the governing documents, which is a very time consuming process. To migrate "Go To Meeting" to "Go To Webinar," platform. Turkey vultures.

CRC: No representative on NAC.

Horsepen Run: No representative on NAC. County easement - LC may extend the Heritage Trail.
