Grounds - Last meeting was two weeks ago. Discussed prioritization of projects with remaining budget.

Facilities - Discussion of latest Sierra Pool proposal to repair skimmer line breaks at Lindenwood Pool.

Discussion of designs and color schemes for the 2 new replacement tot lots at Welbourne and at

CountrySide Blvd. Designs finalized. Colors of green/tan and brown were chosen.

Next meeting is Thursday, November 10th.

BOD meeting - Town Hall Meeting was held virtually 10/25/22 on the proposed amendments to our 3 governing documents. The entire live stream can be viewed through our website at any time. Voting deadline has been extended to Wednesday, Nov. 23rd.

Approved motion to rent electric signs reminding residents to vote on governing documents and amendments and also to purchase 100-yard signs for the same.

CountrySide Management contract was awarded to PMP by a split vote of 4-3.

Annual meeting is scheduled for Monday, December 12th at 8:00 pm.

Second option year of trash contract with AAA/Republic was approved for 2023.

Motion to approve hybrid NAC meetings beginning in January 2023 was approved.

No more BOD meetings in 2022, any emergency votes will be handled with E-votes.
