Standing Committee Reports

Facilities (FAC) - there is a committee vacancy for Oatlands and 2 other neighborhoods; the pool vendor has been dealing with skimmer repairs to Lindenwood; a water pipe burst at Parkway pool and repairs are underway;

Grounds (GRNDS) – work was done at year end to use remaining 2022 funds; a lime application to areas to be determined will be done in the spring; clean up of the river rock in the median at CountrySide Blvd and route 7 was done; clean up of dead and dying trees completed; under trail



drainage cleared; and a grant was approved from Va Forestry to plant trees around the pond, volunteers are needed to help with the planting – planned for April 22nd.
