 - The Chocolate Chick to send proposal. Offers s'mores stations.
 Table-top fire sources run by biofuel with graham crackers, marshmallows, and Hershey bars, cold cider, and donut wall. The flame is protected by glass. There are attendants to run the event.
 - PMP to follow-up with funnel cake budget
 - Vanessa suggests apple cider donuts, or pumpkin flavored items.
