FAC – the PMP facilities manager has resigned; discussion on upgrades to, or replacement of, pool security surveillance systems; MOCO app continues to perform well.

BOD – three meetings since last NAC meeting; discussion around a Loudoun County request for an easment for the Safe Route to School proposal and work with the community's lawyer to cover liability concerns; the Board of Directors requested an opinion from the Loudoun County zoning office in regards to our historic status that affects our ability to address short term rentals; BOD requested three bids for work around the Oatlands stream erosion control project; a request from a resident to use common grounds for a for-profit enterprise was denied.

FAC July 13th (Pat Bour):

Jim White, FAC/Grounds Manager has taken a job closer to home. We wish him well – he will be missed. Discussed motion to purchase new security cameras for pools in light of recent break ins. The consensus of the committee was to request PMP to investigate vendors that can provide 24x7 monitoring systems that are hard wired, Wi-Fi, motion sensor, and lighting.

A safe was installed at each pool PKWY – main & wading pool pumps fixed MOKO app working well

NAC Liaison to BOD (Pat Bour):

July 12^{th} : Did not attend. DRC application approval appealed by neighbor. DRC decision was upheld. July 26^{th} :

LoCo requested easement on HOA property for Safe Route to Schools proposals. Our lawyer went to Richmond to lobby for a statute to release HOA's from liability on these easements. Statute passed. Request for opinion from LoCo Zoning on how the 1972 Ordinance applies to STR & commercial rentals of homes in C'Side.

Resolution #287 Due Process Procedures change. Explained on Website & August Courier. Legal Options re: possible sighting of a registered Sex Offender outside CW pool discussed. Input from our lawyer & LCSO. Letter to community in August Courier & on website. Aug 2nd:

Foxfield resident's application for commercial business use on common ground denied 4 - 3. Car detailing company. LLC owner is not owner of TH. Atty advised against allowing for profit businesses to operate on common ground. Foxfield NAC had previously denied the application, DRC had approved. Oatland's streambed beautification project bid to Advantage denied 6 -1. BOD wants 3 bids if over \$5K. Chelmsford Bridge replacement Insurance check arrived.

FIN July 18th (Jeff Kretsch):

Filed for audit extension.

HPR: No report given.
