Finance – Dave Barrie designated alternate chair. Next meeting 20 February.

Facilities – meeting notes Feb 8th, 2024:

- Welcomed Penny Francke back as chair, Pat Bour elected FAC co-chair
- Update on American Pools contract with HOA fine tuning on contract language.
- Discussed pool covers & options for 2024
- Roddy Dean (FIN) requested that FAC decide whether to repair or replace the Lindenwood (LW)
 Pool in 2024. FIN would like decision by April. He shared LW electric bill is 3500 kw greater than
 Parkway (PW) or Cromwell (CW). LW water consumption is 1.5 times greater than PW & CW
 combined.
- Morven & Foxfield tot lots are slated to be replaced in 2024
- WiFi install at CW Pool was postponed because the anticipated problems with the Moko app that prompted its provision did not materialize.
- PW meeting room rental by non-profits discussed. Scott coined the "Community Ambassador Program" for quid-pro-quo services in lieu of rental fees.
- Girl Scout shed in maintenance yard discussed. 2024 contract needs to be signed.
- FAC needs Oatlands & Welbourne reps
- Next meeting March 14th at 7:00pm

Grounds – Welbourne Director Fredrik Wallin is the new Committee chair. All neighborhood signs are about to be ordered. Tim's expert sourcing enabled comprehensive replacement. We're going to



actually regress from the existing wood material to plastic and similar (PVCs) so that CountrySide looks super classy rather than invest in quality upgrades . The stone would have cost about \$70/household, but that apparently wouldn't be "fiscally responsible".
