APPROVAL OF MEETING MINUTES:

Roddy Dean moved that the Board of Directors approve as written the minutes of the Board of Directors Meeting March 27, 2024. Ed McGee seconded the motion. Motion carried unanimously.

CountrySide Blvd Stairs Encroachment

Fredrik Wallin moved that the Board of Directors approve removal of the stairs from Rokeby to CountrySide Blvd which encroach in the VDOT easement. Further, that the Board request that the Grounds Committee make a recommendation on whether or not the stairs should be replaced at an alternate location outside of the easement. New stairs, if recommended, should be planned and ready to be built when the current stairs are removed to minimize the impact of no stairs at all for our residents. Kumar Sangaran seconded the motion. Motion carried unanimously.

Violations

Roddy Dean moved if corrective action is not taken by April 19, 2024 for the attached violations the Board agrees "to suspend the voting rights and the rights to use of the common areas for any period during which any assessment remains unpaid and for a period not to exceed sixty (60) days for any infraction of any of the published rules and regulations of the association" effective April 20, 2024, in accordance with the CountrySide Proprietary Governing Documents, Covenants and Restrictions, Article IV, Section 1 (d).

Additionally, if the violation is not corrected by June 1, 2024 our legal counsel may file for injunctive relief for the violation, and fees and charges, from the court in accordance with the CountrySide Proprietary Governing Documents, Covenants and Restrictions, Article III, Section 3-Enforcement of Governing Documents. Fredrik Wallin seconded the motion. Motion carried unanimously.

FACILITIES:

Tennis DNA Program

Fredrik Wallin moved that the Board of Directors approve the agreement with Tennis DNA to hold instructional tennis classes on 2 dedicated CountrySide courts between the hours of 3:15 pm – 6:15 pm through June 10, 2024, provided they submit proof of liability insurance of \$2 million per occurrence, adding CountrySide as an additional insured. The FAC unanimously approved this request. Roddy Dean seconded the motion. Fredrik Wallin added a friendly amendment if passed, the Board has the possibility to renegotiate to extend through the summer season. Welbourne, Rokeby & Oakridge voted for the motion. Morven voted against the motion, Belmont abstained from the motion. Motion carried
